2.	FORMULATION	56% w/w Tablet of 3 gms. each		
3.	SPECIFICATION	 a. Aluminium Phosphide tablets/pallets conforming to IS: 6438-1980 with up to date amendments. The average weight of 20 Tablets/pallets in any container shall not be less than 60 gms. b. Each Tablet shall be of 3 gms., weight and shall conform to IS-6438-1980 with up to date amendments. Each tablet shall release 1 gm. of gaseous 		
		phosphine, non-explosive and stable on exposure to atmosphere. It shall also emanate Ammonia gas simultaneously. c. The product shall also be ISI marked and of recent manufacture not more than two months old at the time of offering for pre-purchase inspection.		
4.	GUARANTEE	The product shall be guaranteed against any disintegration and deterioration for a period of two years from the date of manufacture.

7.	Quantity	2500 Kg which may increase or decrease depending up on requirement of the Corporation.
