

	SPECIFICATION	Virgin High Density Polythene Monofilament twine with square mesh Bird Proof door nets bordered by rope and having iron rings on top and sides and iron weights
		at bottom. 2.Material:- The raw materials for making twine and ropes shall be virgin high density polythene monofilaments extrusion grade and not reprocessed. 3. Length: 10 Feet.
		4. Breadth: 10 Feet.
		5. Mesh : a) Square mesh and not rhombus. b) Border meshes shall have 2 to 3 salvage ends. 6. Mesh Size : 1Inch with tolerance of + 0.15 inch.
