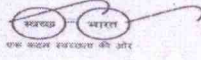

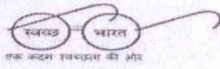

TERMS & CONDITIONS

1.	Description of Stores	Bamboo Mats.
2.	Quantity	20,000 Nos. (Twenty Thousands only).
3.	Specification	Best quality bamboo mats rectangular in shape of 1.524 Mtrs. X 0.914 Mtrs. (5'x 3') size with tolerance limit of + 15.24 cms (6") and 2.54 cms (1") in length and breadth. The mats shall be made from best quality strips which are generally free from any insect attack, fungal attack, broken knot etc. The mats shall be flexible and sufficiently strong.
4.	Weaving	The mats shall be closely woven with minimal inter-strips spaces. The free edges of all strips/leaves should be properly tucked in.
5.	Packing	The mats shall be bundled in multiples of 10 pcs. /bundle for easy counting and handling.
6.	Guarantee	The product shall be guaranteed against any deterioration in quality for a period of six months from the date of supply.
7.	Rate	Rate should be quoted in enclosed annexure-II, inclusive of all taxes, Octroi charges; duties levied or may be levied, packing, handling, Insurance charges etc. FOR destination anywhere in the state of Patna without submission of form "C&D" or any other similar form prescribed under relevant act.
8.	Payment	Payment will be arranged by Regional Manager, Central Warehousing Corporation, Regional Office, Patna, on receipt of pre-receipted bill in duplicate along with receipt certificate and inspection note. In case the material is found defective at destination the same will be replaced immediately at the risk and cost of the supplier. As the payment will be released by this office through e-payment system,

9.	Inspection	The material should be of recent manufacture at the time of pre-purchase inspection. The material shall be offered for pre-purchase inspection within 20 days of issue of the supply order at the site as specified in the supply order.
