SHORT NOTICE INVITING QUOTATIONS

Percentage rate quotations are invited from the interested parties/contractors for the work **Repairs to Culvert near weigh Bridge at CW Ernakulam, Kochi**. Quotation forms, free of cost, can be had from the Executive Engineer, CWC or Warehouse Manager, Central Warehouse, Gandhinagar, Kadavanthara, Ernakulam on any working day up to **4.00 P. M on 23 - 06 - 2017**

The duly filled quotations placed in sealed cover super scribing the name of work on the envelope should reach the **Executive Engineer, CWC, C/o Central Warehouse Ernakulam** on or before **24 - 06 - 2017 up to 3.00 pm** and the same will be opened on the same day at 3.30 pm in the presence of quotationers who may wish to be present. Quotations either by courier/registered post/speed post would be received only up to the closing time. The *corporation* reserves the right to accept or reject any quotation in full or part thereof without assigning any reason.

TERMS AND CONDITIONS:

EXECUTIVE ENGINEER

1. The work should be carried out as per CPWD/BIS specifications and as directed by the Engineer-in-Charge.
2. The income tax, work contract tax and educational cess on tax etc. shall be deducted from the bills as per the statutory requirements.
3. **The service tax or any other tax in lieu thereof by the Central Govt. from time to time on the services rendered by the Contractor to CWC shall be paid by CWC to the Contractor over and above the Schedule of rates, subject to the Contractor submitting his bills /invoices therefore in the Format prescribed under Rule 4A (1) of the service Tax rules, 1994 or other relevant laws, as the case may be.**
4. **The rates quoted to be exclusive of service or any other tax levied by the Central Government in lieu of Service Tax and the same shall be payable by the Corporation over and above the Schedule of rates.**
5. The offer shall open for acceptance for 45 days from the date of opening. The Corporation, without prejudice to any right or remedy, be at liberty to forfeit, 50% of the Earnest Money, if any quotationer withdrawn his quotation before the date or make any modification in the terms

and conditions of the quotation, which are not acceptable to the Corporation and to forfeit whole of the Earnest Money, if the quotationer, whose quotation accepted and fails to commence the work as specified in the NIO (Along with changes in the scope, if any) in the prescribed time or abandons the work before its completion. Further, he/they, himself/themselves would disqualify from participating in the future tender/quotations of the Corporation for the next 5 years.

6. **The work shall be completed within 30 days**
7. Security deposit @ 10% shall be deducted from the bills and will be refunded after a defect liability period of 6 months from the date of completion of the work.
8. Quantity may vary on plus/minus side, as per the actual site condition.
9. During the course of the work, the contractor should take proper care to avoid any damages to the existing structures. In case of damages to the existing structure, the contractor at his own cost shall make the same good to the original condition.
10. The contractor is responsible for the safety of the workmen during the work in progress.
11. No tools and plants or material shall be issued from the CWC stores.
