2. Tenders who wish to participate in e-tender need to fill data in pre-defined forms of Bid in Excel format only.
3. After filling data in pre-defined forms, tenderers need to click on final submission link to submit their encrypted bid.

TERMS AND CONDITIONS

1. The vehicle provided/offered on hire shall be properly serviced and maintained in good condition and all Government Taxes; levies shall be paid up to date at the cost of tenderer.
2. The Driver should be efficient, smart and must possess a valid driving licence and shall be in uniform.
3. The contract shall be for a period of one year from the date of reporting and is extendable for one more year subject to satisfactory performance at the same rate, terms and conditions and on mutually agreed terms.
4. The hire charges shall be payable lump sum basis 3,000 KMs per month and beyond 3,000 KMs, shall be payable per KM basis for actual KM in a month in the Price bid - Annexure-I.
5. The Kilo meter shall be calculated form shed to shed. The Driver shall get the KM recorded and signed by the Customs official at reporting and at the discharge points.
6. The rates to be quoted shall be exclusive of service tax, which shall be claimed and paid wherever applicable at the rates in force from time to time, on production of proper cenvatable invoice.
7. No escalation in the rate shall be considered during the contract period.
8. Levies towards parking, toll charges and other mandatory levies payable during the usage shall be reimbursed at actual on production of receipt for payments.
9. The contractor shall provide the services on all working days including the holidays. They shall also provide additional cars as per requirement.
10. The contract shall make the vehicle available within an hour of intimation. It case if the vehicle in not made available as per the requirement form time to time, penalty shall be imposed besides levy of liquidated damages.
11. In case of complaints and also deficiency in services, the contract can be terminated by giving a month notice by the Manager – CFS. The decision of the Manager – CFS shall be final, conclusive and binding on the contractor and shall not be called into question.
12. An agreement shall be executed by the successful tenderer on non-judicial stamp paper of appropriate value on acceptance of the contract.
13. The Corporation reserves the right to accept/reject any of or all the quotations without assigning any reason thereof.
14. The e- tender to remain open for acceptance for 45 days inclusive of date of opening of tender.
