Sealed percentage rate tenders are invited from approved electrical contractors of appropriate class of MES/CPWD/State PWDs/Public Undertakings/Railways and Govt. Sector Construction Agencies for the following works:-

Tender documents including contract conditions and schedule of work may be down loaded by the interested contractors who wish to participate from the website www.cewacor.nic.in and www.tenderhome.com, upto **14.00 Hrs. on 28.06.2017**. Contractors may also get tender documents issued on production of self-attested copies of Registration and documents as mentioned in eligibility criteria alongwith cost of tender from the office of the EE, CWC, CC, Delhi upto the above mentioned **date & time.** 

## **ELIGIBILITY CRITERIA:**

Contractor who wish to participate should qualify the following eligibility parameters for quoting the rates:-

- 1. Electrical Contractor should be registered in appropriate class of MES/CPWD/State PWDs/Public Undertakings/Railways and Govt. Sector construction agencies.
- 2. Contractor should have completed the similar nature of work i.e. **electrification/repair work of godowns, industrial shed, building work etc.** during the last seven years ending last day of the month previous to the one in which tenders are invited in the concerned Govt. Department/Public Undertaking and completion certificate enclosed as per the following requirement

:5:

- a) Three works each costing not less than 40% of the EC i.e. `.1.06 lakhs OR
- b) Two works each costing not less than **60% of the EC i.e. `.1.60 lakhs** OR
- c) One work costing not less than 80% of the EC i.e. `.2.13 lakhs.
- Contractor must have a minimum average annual financial turnover of `.2.66lakhs (100% of the E.C.) during the last three financial years ending 31<sup>st</sup> March of the previous financial year in which tenders are invited.
- 4. Contractor must produce the Copy of Service Tax registration certificate & PAN Card.

The tender is liable to be summarily rejected and EMD forfeited in case of credential of the contractors in regard to Registration and experience etc. is found to be false.

Tender in sealed cover super scribing the name of the work should reach to the office of the Executive Engineers at above address on or **before 28.06.2017 upto 3.00 PM** and the same will be opened at 3.30 PM on the same day in the presence of tenderers who may wish to be present.

Tenders not accompanied by the Earnest Money (also for working contractors) in the form of Demand Draft & cost of tender documents in the form of demand draft (in case of tender documents downloaded from website) shall be summarily rejected.

The contractor should carefully read General Rules and Directions stipulated in the General Conditions of Contract before submitting their tender. Contractor submitting the tender on behalf of a partnership firm or private Ltd. /Public Ltd. Company must submit the partnership deed and GPA and/or the certificate of incorporation alongwith article of association and memorandum of association alongwith the Tender, otherwise their tender will be treated as invalid.

MSEs registered with the prescribed agencies are exempted from payment of EMD and cost of tender and should enclose the proof of their being registered with agencies mentioned in the tender document. Their registration should be valid as on last date of submission of tender and they should also mention the terminal validity of their Registration failing which their offer shall not be considered for benefits detailed in MSE notification of Govt. of India dt.23.03.2012 or any other notification issued thereafter(Terms for MSE are placed as Annexure-I in GCC)
