ELIGIBILITY CRITERIA:

Contractor who fulfill the following requirements shall be eligible to quote the rates. **Joint Ventures are not accepted.**

1. <u>REGISTRATION</u>

Tenderer should be registered in appropriate class of MES/CPWD/State PWDs/Public Sector Undertakings/Railways and Govt. Sector Construction Agencies and should have electrical license. The registration certificate and electrical license valid on date to be uploaded/ submitted alongwith the tender.

2. EXPERIENCE CERTIFICATE

Tenderer should have satisfactorily completed the **similar nature of work_during** the last seven years ending last day of the month previous i.e. 28.02.2017 in the concerned Govt. Department/Public sector Undertaking and completion certificate uploaded as per the following requirements while submitting the tender on website.

(a)	One similar work costing not less than	Rs. 7.80 lakhs

(b)	Two similar works each costing not less than	Rs. 5.84 lakhs
	or	
(c)	Three similar works each costing not less than	Rs. 3.90 lakhs

Similar work shall mean works of "Electrification in godowns and / or building works".

The value of executed work shall be brought to current costing level by enhancing value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of tender.

3. TURNOVER

Tenderer must have a minimum annual average financial turnover of Rs. 9.73 lakhs during the last three financial years ending 31ST March, 2016 and enclose the Chartered Accountant Certificate for annual financial turnover & audited balance sheet, statement of profit & loss for preceding three financial years with the tender. In case balance sheet and statement of profit for the immediate preceding financial year has not been prepared / audited, the account for one more preceding financial year can be submitted.

4. SERVICE TAX REGISTRATION

The tenderer should have valid service tax registration certificate from the concern authority and copy to be uploaded/submitted alongwith the tender.

5. <u>SOLVENCY CERTIFICATE</u>

Tenderer must have solvency for an amount equal to Rs. 3.90 lakh duly certified by the banker which should not be more than 6 months old prior to the date of submission of tender and to be uploaded/submitted while submitting the tender on the website as per **Annexure-I.**

6. PAN CARD

Tenderer must submit the PAN card alongwith the tender.

7. EMD, COST OF TENDER AND TENDER PROCESSING FEE

Tenderer must submit the following:

For online tender: (a) Cost of tender document should be deposited through E-payment/NEFT and proof to be uploaded with the tender.

(b)EMD should be deposited through E-payment/ RTGS/NEFT mode only and proof to be uploaded with the tender.

(c)Tender processing fee is to be paid mandatorily to the service provider for **e-tender i.e.** M/s KEONICS through e-payment / NEFT through the portal www.tenderwizard.com / CRWC and proof to be uploaded with the tender.

For Offline tender: EMD & Cost of tender document should be deposited in the form of Accounts payee Demand Draft/ Pay order/ Banker's Cheque of a scheduled Bank issued in favour of Central Railside Warehouse Company Limited, payble at New Delhi.

- **8.** Tenderer submitting the tender must submit
 - (a) Copy of Partnership deed and GPA (duly signed by all partner) in case tenderer is a partnership firm.
 - (b) Copy of certificate of Incorporation, Memorandum of Association in case tenderer is a Company alongwith resolution of the company for authorizing the Director/authorized signatory to sign the document submitted. If Authorized Director gives an authority to any other person to sign the tender, copy of Authority letter/ Power of attorney also to be submitted."
 - (c) In case the tenderer is a proprietorship firm, he/ they will submit an affidavit as per Annexure-II.

9. Concession to Micro & Small Enterprises:

Micro & Small Enterprises are encouraged to apply against the NIT. Procurement Policy for Micro and Small Enterprises (MSE's), October 2012, will be adopted, wherever applicable and in accordance with government guidelines related to NITs.

Bidders submitting the quotation under MSE category shall produce the certificate of registration under MSE category with its validity on date of submission of quote/ NIT.

MSE's having valid registration certificate are exempted from payment of tender cost and earnest money deposit.

Tender should be submitted online/offline upto the close time i.e. 3:00 PM on 30.03.2017. Tenderers or their authorized representatives who may witness the opening may attend the opening of tender.

Tenders (technical bid) not accompanied with full documents as per eligibility criteria, cost of tender documents, EMD and tender processing fee not deposited through E- payment mode (In case of online tender) shall be summarily rejected. In the event of any of the documents found tempered/ altered/ forged/ fabricated then the EMD of the contractor would be forfeited and he/ they would be debarred for future participation for the tenders of the works of CRWC for the next five years.

Note:

- (a) In case of Offline mode, tender document should be submitted in two envelopes separately for technical and financial bid duly superscribe on top of the envelopes, alongwith required documents as per eligibility criteria. The contractor should submit all the required documents duly self-attested alongwith the tender.
- (b) In case of online tender contractors are requested to kindly upload the scanned copy of all the above mentioned documents duly self attested alongwith the tender under valid digital signature / certificate.
- (c) The contractor should carefully read the contents of the Notice Inviting Tender and ensure compliance of all requirements before submitting the tender. Non compliance of the instructions/ directions contained in the NIT will lead to rejection of the tender. Contractor should see the site, site condition and time limit for completion before quoting their rate.
