- 1. The works shall be executed as per applicable CPWD Specifications & as per directions of Engineer-in Charge.
- 2. The Water and Electricity (if required) for testing & repairing purposes, Shall be given by the Department free of cost.
- 3. All Tools & Plants as may be required at site shall be arranged by the contractor.
- 4. 10% Security Deposit shall be deducted from the contractor's bill & shall be released after Completion of AMC along with final bills.
- 5. Rates shall be inclusive of all leads & lifts.
- 6. All Taxes such as Income Tax/Work Contract Tax or any other Tax levied by the State Govt. **except Service tax**, as applicable shall be deducted as per prevailing rates from the bills of the Contractors.
- 7. The rates quoted by the party should be inclusive of all taxes, **but exclusive of service tax** as Promulgated by the Central Govt. from time to time.
- 8. The Contractor / Party shall be responsible for safety of workers during the work in progress. No claim in case of accident, miss-happening shall be entertained by CWC.
- 9. The Contractor / Parties may actually visit the site of work & study the site conditions of work before Quoting their rates.
- 10. Corporation reserves the right to accept or reject any or all the quotations without assigning any Reasons thereon.
- 11. The Payments of bills shall be released on **Quarterly Basis** after satisfactory checking, testing and repairing of Lift in all respect as reported by the Engineer in Charge.
- 12. The payments i.e. Running bills / final bills or release of security deposit shall be made by The Executive Engineer, Construction Cell, Delhi.
- 13. The period of the Contract shall be for **01 YEAR** from the date of Actual Handing Over / Taking Over of site and is likely to be extended for a further period of **01 YEAR**, depending upon the performance of the Contract & on the same rate, Terms & Conditions.
- 14. The Materials / Parts required for Maintenance / Servicing from time to time shall be arranged by the contractor at his own cost and nothing extra shall be paid.

- 15. The spare parts used for Repair / Maintenance / Servicing of the lifts shall be of original make / approved brands.
- 16. The Maintenance / Servicing of the lifts shall be done as per guidelines of manual of the Manufacturer.
- 17. The Contractor shall intimate the Names & Address / Telephone number of his own, his service Representative / Service Centre with whom complaint is to be lodged in case of breakdown.
- 18. All normal / minor complaints shall; be attended within 4 hours of lodging of the complaint, However, in case of major breakdown, the lift shall have to be made operational within 24 hours. However, if the Contractor fails to put the lift in operational conditions within 24 hours, the Contractor shall be liable to pay compensation at the rate of double the amount payable per day exceeding 24 hours. The minimum deduction shall be for one day even if the time is less than 01 (one) day.
- 19. The complaints shall be attended on all working days excluding 2nd.Saturdays, Sundays, Gazetted Holidays, National Holidays, normally between 9.30 A.M to 5.30 P.M.
- 20. At the time of attending the complaint, breakdown, The Mechanic of the Contractor shall prepare a Service report in which he shall clearly mention the fault occurred in the LIFT and Spare parts replaced (name of the spare parts) in his report, before leaving the office, after attending to the Complaint, he shall get the signature from the **Lift Operator as well as Draftsman posted at RO**office on the report prepared so. The report should have name of the Mechanic, date and timing of attending the complaint. In case the service report is not signed by the Lift Operator / Draftsman, the Complaint shall be assumed as unattended.
- 21. A logbook shall be maintained by the Contractor to record the behavior of the working of this lift. Every visit / repair, servicing, replacement of any damaged part shall be recorded in the Log Book with the name of mechanic, date and time.
- 22. The spare parts to be used for replacement shall be got checked from the Lift Operator / Draftsman, CWC, Regional Office, Chandigarh.
- 23. All damaged /Unserviceable /Replaced parts shall be taken by the Contractor at his own cost.
- 24. The Quotations must be accompanied by the earnest money deposit (EMD) of **Rs.5000.00** (**Rupees five thousand only**) in the form of Demand draft / Banker's cheque drawn on any schedule bank payable at Delhi, in favor of "**Executive Engineer**, **CWC**, **Const. Cell**, **Delhi** "failing which Quotations shall be rejected

- 2. To regularly examine, lubricate and adjust the equipment and carry out planned Maintenance in systematic and controlled manner by qualified, trained and skilled Employees only.
- 3. To renew all wires, ropes and chains (where fitted) as required to maintain an adequate factor of Safety to equalities the tension on all hoisting ropes, repair/replace conductor cables, hoist way, and machine room elevator wiring.
- 4. To furnish lubricants as per the manufacturers specifications.
- 5. To examine periodically all safety devices and governors and make all customary safety tests and to submit a certificate regarding the safety.
- 6.
