## **TERMS AND CONDITIONS:**

- 1. The work should be carried out as per CPWD/ MNRE/ TEDA specifications and as directed by the Engineer-in-Charge.
- 2. The taxes shall be deducted from the bills of the contractor as applicable from time to time.
- 3. The service tax or any other tax in lieu thereof by the Central Govt. from time to time on the services rendered by the Contractor to CWC shall be paid by CWC to the Contractor over and above the Schedule of rates, subject to

the Contractor submitting his bills /invoices in the prescribed Format of the service Tax rules, 1994 or other relevant laws, as the case may be.

- 4. The rates quoted to be exclusive of service or any other tax levied by the Central Government in lieu of Service Tax and the same shall be payable by the Corporation over and above the Schedule of rates.
- 5. The offer shall open for acceptance for 60 days from the date of opening.
- 6. The work shall be completed within 20 days from the date of issue of the work order.
- 7. Security deposit @ 10% shall be deducted from the bills and will be refunded after a defect liability period of 6 months from the date of completion of the work.
- 8. Quantity may vary on plus/minus side, as per the actual site condition.
- 9. During the course of the work, the contractor should take proper care to avoid any damages to the existing structures. In case of damages to the existing structure, the contractor at his own cost shall make the same good to the original condition.
- 10. The contractor is responsible for the safety of the workmen during the work in progress.
- 11. No water and electricity will be supplied from CWC sources.
- 12. No tools and plants or material shall be issued from the CWC stores.
- 13. Cleaning materials like soft cloth, water, mild degergent, petroleum jally, distelled water etc will be arranged by the AMC/Contractor at his own cost.
- 14. Any types of fault of solar street light system at CW Cuddalore shall be rectified immediately by the AMC contractor after getting intimation from the warehouse manager CW Cuddalore.
- 15. Payment of AMC will be released half yearly basis i.e 50 % after completion of six month and balance 50 % after completion of one year.
- 16. During AMC period the cost of replacement of the damaged /unserviceable parts of solar street light system shall not be covered under AMC i.e cost of replacement of the damaged /unserviceable parts/ accessories of solar street light system will be extra.
- 17. The warranty of Battery shall be five years.
- 18. The warranty of solar street light luminaries shall be one years.
