2.0 E-procurement

2.1 Digital Signature: The Bidder shall require Class-III Digital Signature/ Digital Security Certificate for participating in Corporation's e-tendering process (for login, downloading & uploading of Bid documents or for submitting the e-Bid documents). Digital Signature can be obtained from any of the certifying authority of controller of certifying authority of Govt. of India. The details of CCA may be obtained from the website www.cca.govt.in. For any support required on DSC BIDDERS MAY VISIT "Contract US" section of the above portal.

2.2 This bids being processed through e-tendering/e-procurement system. The Bid documents are to be downloaded, filled & uploaded through e-tendering system of Corporation at the website www.tenderwizard.com/CWC. If any Bidder wishes to participate in the Corporation's tenders, Bidder has to register (**if not registered earlier**) through the refundable registration Fee of **Rs 5000/- (Rupees Five Thousand only) (excluding service tax, presently @ 15%)** in favour of **"K.S.E.D.C. Limited "payable at Bangalore or through online mode of payment.** In case of Joint Venture, Bidder is requested to register with M/s. K.S.E.D.C. Limited in the name of Joint Venture only. The registration fee is payable once on a yearly basis.

The detailed procedure for the registration is as under:

- a. Go to the [url : www.tenderwizard.in/CWC](http://www.tenderwizard.in/CWC)
- b. In the home page click on Vendor Registration
- c. In the Vendor Registration form, vendor has to fill up the applicant details, digital signature information as well as Demand draft details.
- d. After submission of the form, the User-id and password are generated in the form of Acknowledgement.
- e. **Registration Fee** – An amount of Rs.5,575/- (Rupees Five Thousand Five hundred and Seventy five only) inclusive of Service Tax in favour of M/s KSEDC Ltd. payable at Bangalore towards registration fee shall be paid through any one of the following mode:
- f. **Processing Fee:** An amount as reflecting in the online e-tendering module shall be paid through any one of the following mode:
- g. By way of e-payment- By using credit card/debit card and through internet banking. Payment shall be subject to realization by due date and time.
- h. By way of NEFT- Through the banks by downloading the challan available in the website. This mode of payment may take two to four working days; hence, the tenderers are advised to ensure that the payment reaches in concerned account by scheduled date and time. Payments shall be subject to realization by due date and time.
- i. The User-id and password would be activated by M/s **K.S.E.D.C. Limited**, only after receipt of the DD at the above mentioned address for registration enquiry whether DD has received or not, and to activate user ID.

2.3 Cost of tender for 1000/- in the form of Accounts payee Demand Draft/Pay order/Banker's Cheque of a Nationalized or scheduled bank issued in favour of Central Warehousing Corporation payable at Navi Mumbai or through e-payment/NEFT/RTGS. Proof to be uploaded with the tender.

2.4 Tender Processing **Fee of Rs.575/-**{Non-refundable} (or as decided by KEONICES) for each tender in the form of Demand Draft issued by any of the nationalized bank drawn in favour of K.S.E.D.C. Limited, payable at Bangalore and it has to delivered to Regional Manager, "Central Warehousing Corporation, REGIONAL OFFICE CWC, CFS, DISTRI PARK, PLOT NO. 1, SECTOR 07, DRONAGIRI NAVI MUMBAI – 400 707 before the date and time set for closing of the tender document or bidders can pay directly online. Those bidders who failed to submit the tender processing fee to M/s. KSEDC Limited their bid would not made available by the system and shall not be considered during the opening of the tender.

2.5 All the bidders are requested to get themselves registered well in advance and no extra time will be considered for the delay in on-line vender registration, if any. In case bidder wait till the last moment for uploading tender, and if any technical problem is encountered at the time, the bid closing time may elapse.

NOTE:-

If the date fixed for opening of the tender is declared a holiday, the tender will be opened on the next working day following the holiday but there will be no change in the time for opening as indicated above.

The Regional Manager, CWC, RO, Navi Mumbai, may at his discretion extend this date by a fortnight and such extension shall be binding on the tenderer.

The tender (quoted rates) shall be valid for acceptance for period of 90 days from the date of opening of technical bids.

If the date up to which tender is open for acceptance happens to be a holiday, the tender shall be deemed to remain open for acceptance till the next following working day.

If any Tender is withdrawn or modified before, the date up to which the tenders are valid for acceptance, the Earnest Money or the tender shall stand forfeited and the tender shall be summarily rejected.
