TECHNICAL BID

The tenderers shall furnish the following documents in the technical Bid.

- 1. Experience for conversion & up-gradation of Electro mechanical/Mechnical/Electionic LWB in to fully Electronic lorry weighbridge with the capacity of 30 MT or above in Govt./Public Sector Undertaking/reputed public limited/Listed companies is mandatory. The tenderer shall furnish at least 02 nos. of completion certificate for having executed such work in Govt./PSU/reputed public limited/Listed companies and their performance certificates of the converted LWB along with tender
- Copy of valid License issued by Weights & Measure Department for manufacturing/repairing/servicing of electronic lorry weighbridges in their name. License should be possessed for repairing and servicing for the ELWB as per the standards of Weights and Measure Act.
- 3. Submit GST registration of Certificate obtained from authorities of the state/Central Govt, as applicable.
- 4. Copy of PAN card
- 5. Cost of tender form Rs. Rs. 1,180/- (Rs. One Thousand One Hundred Eighty only) includes GST by way of Demand Draft/Bankers cheque from nationalized/scheduled bank in favor of Regional Manager, Central Warehousing Corporation, payable at Raipur.
- 6. EMD: Rs. 20,000/-(Rs. Twenty thousand only) in the form of Demand Draft/ Bankers cheque from nationalized/scheduled bank in favor of Regional Manager, Central Warehousing Corporation, payable at Raipur.
- 7. MSMEs registered with the prescribed agencies are exempted from payment of EMD and cost of tender and should enclose the proof of their being registered with agencies mentioned in the tender document. Their registration should be valid as on last date of submission of tender.

Those who fulfill the above criteria will be declared as technically qualified tenderer and their Rate Bid (Price Bid) will be opened. Those who do not fulfill the above criteria shall be disqualified and their price bid will be not opened and their sealed price bid will be returned to them.

The parties shall offer the material strictly conforming to the specification, terms and conditions. The tenders not conforming to the strictly as per the technical specification, other term & conditions of the enquiry and incomplete/conditional tenders will summarily be rejected as invalid. Further in order to assess manufacturing facilities available with the tenderer, the inspection of facilities may be required to be arranged by the party at the discretion of the corporation.

In the event of any document found fabricated/forged/tampered/altered/manipulated during verification, the EMD of the bidder shall be forfeited and he/they/himself/themselves would be disqualified for future participation in the tender of Central Warehousing Corporation works for the next 02(two) years.

TERMS & CONDITION FOR CONVERSION AND UP-GRADATION OF EXISTING OF 02 NOS 30 MT MECHANICAL LORRY WEIGH BRIDGE INTO 60 MT FULLY ELECTRONIC LORRY WEIGH BRIDGE.

- The tender is to be submitted in two parts, Part-I containing 'Technical bid' and Part-II containing Price bid, (each part to be sealed in separate covers clearly marked Part-I and Part-II i.e. Technical bid and Price bid). Both the covers are to be kept in another cover which shall be duly sealed and superscripted "TENDER FOR CONVERSION AND UPGRADATION OF EXISTING 30 MT MECHANICAL LORRY WEIGH BRIDGE INTO 60 MT FULLY ELECTRONIC LORRY WEIGH BRIDGE".
- 2. Scope of work: Conversion and Up-gradation of existing 30 MT Mechanical Lorry Weigh Bridges to 60 MT fully electronic LWB including Commissioning/Stamping/Testing and required civil & electrical work installed at Central Warehouse Raipur-III and Raigarh-I. Height of platform of LWB shall be raised with construction of ramp and Foundation pillar, filling of existing pit, replacing/erection of new girders if any and any other civil work.
- 3. Original testing certificate of the load cells should be produced before taking up the conversion & up-gradation work as per specification given.
- 4. The all work conversion & up-gradation including Commissioning/ Stamping/Testing and required civil & electrical work of lorry weighbridge in to 60MT fully electronic weighbridges should be completed within 45 days.
- 5. Warranty period: One year from the actual date of stamping.
- 6. **Services:** During warranty period any breakdown of the converted Electronic lorry weighbridge must be attended within 24 hours for rectification of defect at the call of concern warehouse managers failing which the weighment charges will be recovered from the party.
- 7. **Reimbursement of Govt. Stamping fee:** Actual Govt. stamping fee will be reimbursed by CWC on production of original receipt. Re-stamping fee/charges of ELWB, if any, due to break down etc. will be borne by the party.

Tender not accompanied by EMD will be summarily rejected. The EMD will be forfeited in the event of the tenderer withdraws his tender or backs out after acceptance of the tender or fails to remit the Security Deposit or Non execution of the contract or if the tenderer revises any of the terms quoted during the validity period.
