1	Description of store	ISI marked Chloropyriphos 20% EC
2	Quantity	350 lits
3	Formulation	20% Emulsifiable concentrate.
4	Specification	IS 8944-2005 with up-to-date amendments. The Product shall be ISI marked and of recent manufacture.
5	Guarantee	The product shall be guaranteed against any deterioration in quality for a period of two year from the date of manufacture.
6	Packing	The material shall be packed in 5 ltrs. container strong enough to withstand rough handling in transport.
7	Marking	The containers shall bear legibly & indelibly the information about the product.
8	Rate	The rate shall be quoted per liter in 5 ltrs. packing inclusive of GST & cost of packing, handling, insurance charge e.t.c. & FOR destination.
9	Destination	Inspected & approved store shall be despatched to the Warehouse Manager, Central Warehouse, IMPORT-EXPORT, Kolkata-700043. The store received in damaged condition at the destination will have to be replaced by the supplier at his risk & cost.
10	Inspection & acceptance	The above-required quantity of Chloropyriphos 20% EC shall be tendered for pre-purchase inspection to this office immediately after receipt of supply order. The store in no case to be dispatched before the same has been inspected by Central Warehousing Corporation & written confirmation given by them that the same conforms to stipulated specifications & are acceptable. The Corporation may at its discretion draw random samples in respect of supplies made and get them tested by any Recognized laboratory etc. The lab Testing Charges shall be borne by the supplier. The supplier shall have to furnish an undertaking that in case stores not found conforming to specifications at any stage the same will be replaced with good one at his cost. Note: The goods which are not inspected/passed by the Inspecting Officer shall not be accepted. Post purchase Inspection has to be conducted at the receiving end by the concerned staff, which will be reported on the receipt certificate. The payment to the supplier will be released only after the confirmation of receipt of consignment in good condition.
11	Payment	The payment will be arranged by the Regional Manager, CWC, RO, Kolkata on receipt of duly certified pre-receipted bill in duplicate on completion of delivery along with receipt certificate from the consignee of having received the material in good condition. Pre-receipted (original bill) in duplicate (containing details as required under GST rules) has to be submitted to the consignee so as to enable them to forward the same to this office for payment. In case the material is found defective at destination the same will be replaced immediately free of cost. The payment will be released by this office through ECS system. Note:-The following information /particulars may please be submitted along with the Tax invoice(bill).
