Electronic Lorry Weigh Bridges 60 MTC at Central Warehouse, Gulbarga-II, Gadag-II, Hubli, Dharwad & Davangere and 02 No. of ELWB 40 MTC ELWB at CW, Mangalore-I & Gulbarga-I.

Terms and conditions of the AMC

Important: Tenders shall be submitted in a sealed cover duly super scribing Tender for AMC for Electronic Lorry Weighbridges and last date 24.09.2018.

- 1. Scope: Service and Maintenance of 05 Nos. 60 MTC Electronic Lorry Weigh Bridges at Central Warehouse, Gulbarga-II, Gadag-II, Hubli, Dharwad and Davangere and 02 Nos. 40 MTC at CW, Mangalore-I & Gularga-I. The bidder shall maintain all 07 weigh bridges in trouble free condition without any variation in Weighment and avoid any penalty from the Department of Legal Metrology. The ELWB shall be ready for inspection by the authorities at any time. The bidder shall arrange quarterly serving and maintenance once in three months in a year. The bidder shall attend to all emergency calls for rectification of defects reported by the respective Warehouse Manager, within a reasonable time to avoid Weighment on outside ELWB, in addition to quarterly service. The bidder shall be capable of replacing any spares damaged or not functioning in the ELWB. The bidder shall arrange inspection of ELWB which are due for annual stamping. Painting of platform, border frame annually before stamping.
- 2. **Period of Contract** Two years with a provision to extend for 3 months on satisfactory performance during contract period.
- 3. Inclusion: All minor spares, Board and Card of Digital Indicator included. Expenditure in deputing service engineer to the site for service and maintenance and for preparation of ELWB for stamping. Annual painting of platform and external metal parts included.
- 4. Exclusion: Spares which are not covered under AMC. Junction box, Load cell, Worn out Bolt and Nut. Unskilled labour, UPS and batteries, Computer and Printer, Jumbo display unit. Any parts which are damaged by fire, flood, Lightning and high power flow are not covered under AMC.
- 5. Stamping: Stamping fees on actual basis will be paid by CWC. However the service provider shall arrange inspection by the Department of Legal Metrology and stamping of ELWB on or before due date annually. Incidental charges for arranging stamping payable to Service Provider.
- 6. AMC RATE: The bidder shall quote AMC rate in the price bid form showing taxes separately.
- 7. Payment: Payment for AMC will be on quarterly basis, after completion of each quarterly service and production of service voucher counter signed by the Warehouse Manager or Incharge of the respective Warehouse. Bill shall be certified by the Warehouse Manager. If the service provider fails to undertake servicing for a particular quarter, he will not be entitled for quarterly service (AMC) charges for the particular quarter. Not attending quarterly servicing will be treated as breach of agreement.

- 8. Validity: Rate quoted shall be valid for one month.
- Tender acceptance/rejection: The RM, CWC, RO, Bangalore shall have the right to reject all or any tender without assigning any reasons thereof.
- 10. EMD/SD: An amount of Rs.5000/- shall be submitted along with tender form. Tender without EMD will be summarily rejected. MSEs registered with the prescribed agencies are exempted from payment of EMD and should enclose the proof of their being registered with any agencies under Ministry of MSME. Successful bidder shall pay SD of Rs.25000/- or 5% of the tender value whichever is higher, after adjusting EMD on award of AMC. The SD will be returned to the bidder after two years (or completion of contract period) without any interest.
- 11. Last date: for submission at 3.00 PM on 24.09.2018. Bids will be opened at the same day at 3.30 PM in the presence of bidders who are interested to participate at their own cost at Regional Office, Bangalore

12. Eligibility Criteria:

- a) Bidder shall submit a copy of Work order for having experience in the field of AM C of ELWBs either in CWC or from any State Warehousing corporation for a minimum of 5 Nos. ELWBs for a minimum period of one year.
- b) Hold valid license to undertake repairing and servicing of ELWBs in Karnataka. (copy of license to be enclosed).
- c) Submit copy of PAN card.
