All the field trips will be conducted from Hapur. During the field trips participants will go in the early morning from Hapur to the desired place and in the evening will come back to Hapur by bus.

For the visit to ICP Attari, all the participants are requested to book their rail tickets by Swarna Shatabdi (12029) to be departured from New Delhi at 7.20 AM & destined to Amritsar on same day i.e. 10.08.2017. Participants are also requested to arrange their return journey from Amritsar to their respective place of posting on 11.08.2017 after 12.30 PM. Bus facility will be provided by CWC from Hapur to New Delhi Rly.Station. Similarly bus facility will be provided from Amritsar to Attari and vise-versa

All the Management **Trainees are advised to attend** this training programme compulsorily **as this is part of their One Year Training Programme.** They are advised to report for training on **26.07.2017 at 9.45 a.m**. sharp in the CWC's Lecture Hall at IGMRI Campus, Hapur in order to get full benefits of training.
