- 1. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

- 7. If the firm of the participating bidder is registered as "Partnership", then the firm has to submit the proof regarding registration of the firm, old as well as latest partnership deed and Authority letter to sign the Bid document along with other documents sought in the bid.
- 8. Following bidders are exempted from submission of EMD-

- 13. The Bidder has to submit CA Certified Net worth Certificate of last audited financial statement.
- 14. All Participating bidders has to submit an undertaking that his firm has not been blacklisted or otherwise debarred or terminated by CWC, FCI or any department of Central or State Government or any other Public Sector Units during last 05 years as on the last day of submission of bid in prescribed format placed at Annexure-II.
- 15. The bidder shall upload/furnish the following documents along with the bid-

- 16. The seller shall re-offer the pre-purchase inspection immediately if samples drawn during pre-purchase inspection fail during lab testing. Store will be accepted only on being found in conformity during testing.
- 17. Testing of sample: Testing of sample drawn during pre-purchase inspection will be carried out at NABL accreditated lab on the choice of buyer's. Lab testing charges to be borne by the supplier.

Remarks-

- a) The bidder shall sign the bid security declaration accepting that if they withdraw or modify their bid during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit the performance security before the deadline defined in the bid document, they shall be de-barred from p articipating in any of the tenders /procurement process of CWC for a period of **two years**.
