:: EXPRESSION OF INTEREST FOR HIRING OF GODOWNS & REGISTRATION ON CWC DOMAIN WEE@CWC ::

Central Warehousing Corporation (CWC), established under Warehousing Corporation Act, 1962, functioning under the Ministry of Consumer Affairs, Food & Public Distribution, Government of India, has been established for the purpose of Warehousing of Agriculture Produce and other notified commodities. Presently, CWC is operating 420 Nos. of Warehouses across the country with a storage capacity of 11.54 Million Tonnes providing services for a wide range of products ranging Foodgrain Warehouses, Industrial Warehouses, Custom Bonded Warehouse, Container Freight Stations, Inland Clearance Depots and Air Cargo Complex. Apart from storage, CWC also offering the services in the area of Handling & Transportation, Clearing & Forwarding, Procurement & Distribution, Disinfestation Services, Fumigation Services and other Ancillary Activities.

CWC is interested to hire the godowns to store foodgrains and other notified commodities at various locations in the State of Gujarat as per prescribed Terms & Conditions. The model agreement to be executed between CWC & Godown owner shall be provided at later stage. As such, CWC hereby invites **Expression of Interest** from the interested and eligible parties, who intend to Offer readily available godown of atleast 15000 MT capacity (Minimum 90,000 SQFT covered godowns)

CWC has launched online portal namely Warehouse Aggregation Portal i.e. WEE@CWC (http://www.weecwc.in/) for hiring of godwns, wherein, the bidder has to register himself on the given portal and has to submit their proposals through the said portal. The registration on above portal is free of cost.

The offers received from bidders will be examined and analyzed on the basis of their proposals and its economic feasibility to CWC.

➤ Interested parties are advised to register himself on Warehouse Aggregation Portal and to enter godown details. Besides, bidder also has to send their proposal "Expression of Interest"

- in the prescribed pro-forma along with enclosing necessary document, which is enclosed herewith for ready reference.
- ➤ The godown should have been scientifically constructed on elevated area and storage worthy for foodgrains and other notified commodities to the satisfaction of CWC.
- ➤ There should be proper approach road upto the godowns from the main highway. Similarly, there should be adequate internal roads to facilitate easy movement of trucks.
- > Godowns should have following supporting facilities:
 - Office Block
 - o Minimum 60 MT Electronic weighbridge
 - o CCTV surveillance
 - o Proper drainage
 - o Boundary wall / fencing
 - Firefighting equipment
 - o Electricity, Water, Toilets etc.
 - WDRA registration (It is desirable to have godown registered under WDRA, however, the godown owner may undertake to get registered under WDRA at the time of execution of agreement, in case of godown not registered under WDRA.)

The tenderer has to quote their rate in the enclosed format.
