1. The total monthly remuneration and the pension drawn by the Retired employees shall not be more than the last pay drawn by him calculated at the current rates of dearness allowance.
2. The higher grade pay granted under MACP (Modified Assured Career Progression Scheme) by the last organization shall not be taken into account for determining eligibility criteria in accordance of pay scale and grade.
3. The Advisor would be entitled for TA/DA as per the CRWC Procedure and Guidelines for Engagement of Retired Employees.
4. Vigilance Clearance is required at the time of submission of application. In case a retired officer had served in more than one organization, vigilance clearance should be obtained from all organizations where the retired officer has served during a period of 10 years prior to his retirement.
