Presently, all the expenditures incurred on the Daily allowance and lodging charges i.e hotel and travelling incurred on Branch Auditors are being debited in the corporate office.

With effect from F/Y 2017-18 due to implementation of GST, above expenditures shall be debited and charged by Regional Offices in their accounts instead of sending debit advice to corporate office. For this purpose new account Head "R743- Travelling Expense Auditors" shall be opened in the books of Regional office in Part-A of Trial Balance.

The Circular may be brought to the notice of all concerned for scrupulous compliance.
