Corrigendum to Accounting Circular # 28

Subject: <u>Accounting of Income, Expenditure, Payable and Recoverable at CFS/ICDs under Strategic Alliance Management Operator (SAMO) at CFS/ICDs.</u>

Thus is with reference to the Accounting Circular # 28 dt 15.04.2020, relevant to SAMO accounting.

Under Arrangement No 1 -At all SAMO locations wherever the billing is done in the name of CWC ,following procedure is to be followed for accounting of TDS deducted by the customers on bills of CWC:

- a.) Centre wise and SAMO wise TDS Control ledgers shall be opened under the Group "29110 TAX DEDUCTED AT SOURCE- CONTROL A/cs"
- b.) Regional office shall Debit all the TDS deducted by Parties related to a particular centre and SAMO under this particular TDS control ledger instead of debiting to year-wise ledger of TDS Control Accounts (as per existing practice).
- c.) Entry for booking TDS shall be passed as under
 - i. For receiving payment against CWC income

ii. For transferring reflected TDS from control to availament a/c

d) In no case, TDS deducted by the SAMO Customers be booked under year-wise ledger of TDS Control A/c.

All other procedures and entries as specified in Accounting Circular # 28 shall remain same.

No deviation shall be acceptable of above accounting procedures.
