Sub: Reservation for Economically Weaker Sections (EWSs) - reg.

In terms of DPE OM No. 20(10)/99-DPE-GM-Part-2019-FTS-1517 dated 25.01.2019 and DOPT OM No. 36039/1/2019-Estt.(Res) dated 19.01.2019 (copies enclosed) on the subject mentioned above, with the approval of the Competent Authority it has been decided that 10% reservation for Economically Weaker Sections as per Govt. guidelines will be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019. The detailed instructions mentioned in the OM dated 19.01.2019 and the guidelines issued by the Govt. on the matter from time to time may please be referred for compliance.

Above guidelines shall be followed by all concerned.

Subject:- Reservation for Economically Weaker Sections (EWSs) in Central Public Sector Enterprises (CPSEs) posts.


In continuation of DPE OM of even no. dated 25-02-2015 regarding extension of the instructions issued by Government in respect of reservation to SC/ ST/ OBC/ PwD & Ex-servicemen to all the CPSEs, the undersigned is directed to state that the instructions issued by DoPT vide its OM No. 36030/1/2019-Est.(Res.) dated 19-01-2019 and DO of even no. dated 21-01-2019 (copies enclosed) in respect of reservation to Economically Weaker Sections (EWSs) are also to be taken as *mutatis mutandis* extended to all the CPSEs.

2. In this regard, all Ministries / Departments are requested to advise all CPSEs under their respective jurisdiction to ensure that 10% reservation for EWSs as per the provisions of OM dated 19.01.2019 of DoPT would be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019.

3. As clarified by DoPT in the OM dated 19.01.2019, the detailed instructions regarding operation of roster and procedure for implementation of EWSs reservation will be issued separately. All administrative Ministries / Departments are also requested to submit Fortnightly Report in respect of CPSEs, beginning from 15.02.2019, to DoPT as per format given in DoPT DO dated 21.01.2019.

4. This has the approval of the Competent Authority.

OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) in civil posts and services in the Government of India

Reference is invited to Ministry of Social Justice and Empowerment O.M. No. F.No.20013/01/2018-BC-II dated 17.1.2019 on the above mentioned subject, which, inter-alia, reads as under:-

"1. In pursuance of insertion of clauses 15(5) and 16(6) in the Constitution vide the Constitution (One Hundred and Third Amendment) Act, 2019 and in order to enable the Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes, to receive the benefits of reservation on a preferential basis in civil posts and services in the Government of India and admission in Educational Institutions, it has been decided by the Government to provide 10% reservation to EWSs in civil posts and services in Government of India and admission in Educational Institutions.

2. Persons who are not covered under the existing scheme of reservations for the Scheduled Castes, the Scheduled Tribes and the Socially and Educationally Backward Classes and whose family has gross annual income below Rs. 8.00 lakh are to be identified as EWSs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWSs, irrespective of the family income:

- i. 5 acres of Agricultural Land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

3. The income and assets of the families as mentioned in para 2 would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs. The officer who issues the certificate would do the same after

carefully verifying all relevant documents following due process as prescribed by the respective State/UT.

5. Instructions regarding reservation in employment and admission to educational institutions will be issued by DoPT and Ministry of HRD respectively.

2. In pursuance of the above Office Memorandum, it is hereby notified that 10% reservation would be provided for Economically Weaker Sections (EWSs) in central government posts and services and would be effective in respect of all Direct Recruitment vacancies to be notified on or after 01.02.2019.

3. Detailed Instructions regarding operation of roster and procedure for implementation of EWS reservation will be issued separately.
