Sub: Extension of Scheme of Reimbursement of medical expenses for OPD treatment out of fund from CWC Employees Benevolent Trust for the financial year 1.4.2015 to 31.3.2016

Sir,

In supersession of letter No. CWC-EBT/Med. Reimb.C&D/2015-16/832D dated 21/07/2015, vide which the scheme of medical reimbursement for OPD expenses for chronic diseases was conveyed, it has been decided in the 17th meeting of CWC EBT held on 13.07.2015, (vide agenda item No. 3) to continue the reimbursement of OPD expenditure for chronic diseases (for all the diseases circulated vide circular dated 19.9.2000 of CWC) and to extend to all employees of the Corporation, for the financial year 1.4.2015 to 31.3.2016 as per following modifications:-

Reimbursement for the period 1.4.2015 to 31.3.2016:-

1. Employees incurring expenditure on Chronic Disease upto first Rs.10,000/- for the period 1.4.2015 to 31.3.2016 NIL re-imburement
2. Employees incurring expenditure from Rs.10,001/- to Rs.60,000/- or above , for the period 1.4.2015 to 31.3.2016 Rs.50,000/--(maximum) or actual whichever is less

- a) The expenditure w.e.f. 1.4.2015 to 31.3.2016 shall be reimbursed to all employees subject to above limit given at 1 & 2 above, provided the first diagnosis/consultation is obtained from Govt./Govt. recognised Hospital, as already decided by the trust.

- b) The reimbursement of Medical expenses for OPD expenditure in respect of chronic diseases for the period 1.4.2015 to 31.3.2016 shall be made on proportionate basis for the actual period of service rendered by employees, during Financial Year 2015-16, subject to above limit given at point 2 above.

In the 17th meeting of CWC EBT held on 13.07.2015, it was decided (vide agenda item No. 3) to continue the reimbursement of OPD expenditure for chronic diseases (for all the diseases circulated vide circular dated 19.9.2000 of CWC) to group C & D employees for the financial year 1.4.2015 to 31.3.2016 as per following modifications:-


Reimbursement for the period 1.4.2015 to 31.3.2016:-

1. Employees incurring expenditure on Chronic Disease upto first Rs.10,000/- for the period 1.4.2015 to 31.3.2016 NIL re-imburement
2. Employees incurring expenditure from Rs.10,001/- to Rs.60,000/- or above, for the period 1.4.2015 to 31.3.2016 Rs.50,000/-(maximum) or actual whichever is less

✓ The expenditure w.e.f. 1.4.2015 to 31.3.2016 shall be reimbursed subject to above limit given at 1 & 2 above, provided the first diagnosis/consultation is obtained from Govt./Govt. recognised Hospital, as already decided by the trust.

Based on the above decision, ROs/CCs/CO shall reimburse the medical expenses for the claims received/ to be received during this period of 1.4.2015 to 31.3.2016 to Group C&D employees on account of chronic diseases for OPD expenditure.

The reimbursement of Medical expenses for OPD expenditure for the period 1.4.2015 to 31.3.2016 shall be made on proportionate basis for the actual period of service rendered by employees, as Group C & D employee.



Accordingly, it is requested that Regional Office/Construction Cell/Finance Division. Corporate Office shall claim amount of OPD expenditure from EBT Section. Corporate Office, New Delhi for the period 1.4.2015 to 31.3.2016 after making reimbursement to employees. For this purpose, employee wise details duly certified by Head of Accounts Section of RO/CC/CO shall be provided in the following proforma:-
