CIRCULAR -192

Vide circular No. 174 model tender document was circulated thereafter many amendments in the model tender document had happened. The model tender document has been modified wherein all subsequent amendments post circular No. 174 has been incorporated and some new modifications have also been made. The salient modifications in the model tender for appointment of H&T Contractors are as follows:

- 1. Eligibility has been bifurcated into minimum eligibility criteria and other documents required.
- In Work Experience and Experience Certificate:- The Tenderer should have successfully completed works of above nature of value not less than Rs____(35% of the total estimated value of the contract in one single contract) during preceding five years and current year upto date of submission of tender.
- 3. In Turnover :-The average turnover of preceding three financial year should not be less than 30% of the estimated annual value of contract.
- 4. Tenderers not having stipulated experience can participate in H&T contract, where the total estimated value of contract for Handling & Transport is less than Rs. two crores. In such cases tenderers can submit Appendix- X in lieu of experience certificate at Appendix- III.
- 5. In clause [XVI] (c) of <u>Payment</u>: The payment shall be made by the Corporation after realisation of the amount from the concerned depositor. The Corporation shall not be liable for payment of any interest on any bill outstanding for payment.
- 6. The MSME must indicate the terminal validity, if applicable.
