**CIRCULAR**

**Sub: DoP for Pest Control Services- reg.**



With the approval of the Competent Authority, the following Delegation of Powers is affected for PCS work. New DoP alongwith the relevant instructions is as under:

**1. General Instructions**

- (i) HoD/PCS Division and RM of the GM level, will exercise the power of GM.
- (ii) PCS Cell Incharge in the field will exercise the power of Warehouse Manager (below 15000 MT category).
- (iii) RM will exercise the power of DGM where the RM of the rank of AGM/Manager is posted in the region.
- (iv) The technical incharge of the regions having profit more than Rs. 1 Crore under PCS head will exercise the power of AGM and others below one Crore profit will exercise the power of Manager. Technical incharge of the rank of AGM and above posted in the region will exercise the power as per DoP.

**2. AMENDMENTS IN THE EXISTING DOP**

- (i) **PROCUREMENT** - The RO will exercise the power as mentioned at page No. 24 of the existing DoP, Item No. 12.0.
- (ii) **PUBLICITY** - In the existing DoP Item No. 30 (i) & (ii), at page No. 83 is related to publicity, advertisement. For the publicity of Pest Control Services, Item No.30(iii) has been inserted after 30(ii) at page - 83 of the existing DoP detailed as under:
