
In continuation to the Trust circular No. CWC-EBT/Med.Reimb/2015-16 dated 14.09.2015 and 656D dated 18.01.2016, it has been decided in the 18<sup>th</sup> meeting of CWC Employees Benevolent Trust that the first prescription/diagnosis of CWC nominated hospitals of Corporate Office and Regional Offices, will also be acceptable in addition to the prescription of Govt./Govt. Recognised Hospital w.e.f. 25.01.2016 Further, the scheme circulated vide circular No. CWC-EBT/Med. Reimb/2015-16 dated 14.09.2015 is extended for Financial Year 2016-17 at the same rates and the same limits for reimbursement of medical expenditure and the same is reiterated below:-
