Consequent upon their promotion, their pay will be fixed in the aforesaid pay scale in accordance with Regulation 25 of CWC (Staff) Regulations, 1986. In case they want pay fixation on promotion under FR 22(1)(a)(i) i.e. after drawl of next increment in the lower grade they can exercise option for the same within 30 days of their joining the new post; **except for those officials whose pay have already been fixed in the above scale under ACP Scheme.**

The above officials shall be on probation for a period of one year w.e.f. the date of they assume charge of the new post except officials at Sl. No. 6, 7, 8, 18, 19, 31, 44, 47, 63, 66, 73, 87, 88, 90, 92, 98, 99, 112, 114, 118, 125 & 138 who shall be on probation till the date of their retirement. The period of probation is extendable further upto one year as per regulation of 10 of CWC (Staff) Regulation, 1986.



The posting of some of the officials is to be decided by RM as indicated which may be done immediately keeping in view the Vigilance guidelines, Vigilance Circular dated 04.06.2014 and existing guidelines & policies of the Corporation in respect of transfer & posting. The guidelines provides for shifting of official from sensitive posts after three years and from non-sensitive posts after five years.

The officials already upgraded in the aforesaid scale i.e. 11200 - 30600 will not be entitled for pay fixation.

It is also reiterated that the officials who are being promoted, should join their duties within one month (30 days) from the date of issuance of this order, failing which it will be presumed that they are not interested to join on promotion and their promotion will be treated as foregone (Please refer Circular dated 15.02.2012).

The above officials should proceed to their new place of posting and submit their relieving/joining reports to all concerned immediately.
