**CIRCULAR**

Attention is invited towards the provision of the rule 4.4.3 of Defined Contributory Superannuation (Benefit) Pension Scheme regarding resignation of member from CWC and joining another CPSE having approved Defined Contribution Superannuation Scheme or resignation from CWC and joining CPSE having no such scheme or resignation from CWC and joining other organization. A form named as Pension Trust Form No-6 has been devised for filling by such members of the scheme which is to be submitted to Secretary Pension Trust.


The provisions of the rule 4.4.3 of Pension Scheme are as under:-

"In case the member resigns and joins another CPSE, he may exercise one of the following two options and on the basis of such option exercised, the Trustees shall exercise one of the following options to pay the benefits under the scheme to the member.

Transfer the funds received from the insurer pertaining to the member to the approved Defined Superannuation Scheme of the CPSE of which he may become a member within a period of 12 months or applicable period of lien.

If the amount due is not transferred within the stipulated period or on account of CPSE not having an approved Defined Contribution Superannuation Scheme or the member joining service of another organization then the members own contributions including voluntary contributions and growth thereon may be refunded to him after deduction of charges if any and subject to income tax rules as prevalent at the time."

It is requested that all such members may fill up the form no-6 and submit it to Secretary Pension Trust so that the Pension Dues may be settled accordingly.




