3. The issues pertaining to Regional level/ in the jurisdiction of Regional Manager will be discussed in the meeting. Issues related to all India nature/ policy matters will not be discussed.
4. The cases involving vigilance matter/ court case will not be discussed in the meeting.
5. The discussion/ meeting will be restricted to one day.
6. TA/DA will be paid to the participating representatives as per their admissibility.

POLICY FOR HOLDING MEETINGS WITH THE REPRESENTATIVES OF UN-RECOGNIZED BUT REGISTERED TRADE UNIONS.

The meeting with un-recognized but registered trade unions may be allowed as per following criteria:

- a) The meeting will be held once in a year.
- b) The Regional Union will nominate 05 representatives out of the employees of the Region to attend the meeting with the Regional management.
- c) The issue pertaining to regional level / in the jurisdiction of Regional Manager will be discussed in the meetings. Issues related to All India nature/policy matters will not be discussed.
- d) The cases involving vigilance matter / court cases will not be discussed in the meetings.
- e) The discussion / meeting will be restricted to one day.
- f) No minutes of the meetings shall be drawn.
- g) No TA/DA/Spl.CL will be admissible to the participating representatives.
- h) The meeting will be held without dislocation / disturbing the work and maintaining the office decorum.
