(h)</p> <p>The contractor shall be liable to carry out weighment at nearest weighbridge as decided / approved by CWC / FCI where the distance between Goods shed to Warehouse or vice versa is more than 10 kms and ensure proper account of weighment of stocks as per direction of the Warehouse Manager. The contractor is responsible on account of road transit loss found if any while transportation based on weighment conducted between nearest weighbridge of Goods shed and CWC weighbridge.</p>
