**SUBJECT: Modification/Amendments in clause no. 30 at page 66/100 Model
Tender Document(MTD).....reg.**

Sir,

While reviewing the Model Tender Document for H&T tender at Corporate Office it has been observed that there is a need for amendment of clause no. 30 under 'Duties and Responsibility of the Contractor' at page 66/100 of the MTD and with the approval of the Competent Authority, the following changes in MTD are advised to be incorporated with immediate effect.

Existing Clause:-

The contractor shall be responsible for the safety of the goods while in transit in their trucks/ carts/ any other transport vehicles and for delivery of quantity dispatched from the Railhead/ Godowns etc.; as the case may be, to the destination or to the recipients to whom the grain etc.; is required to be transported by the contractor. They shall provide tarpaulins on decks of the trucks, so as to avoid loss of the grain etc.; through the holes / crevices in the decks of the trucks. They shall also exercise adequate care and take precautions to ensure that the foodgrains bags are not damaged while in transit in their trucks/ carts /any other transport vehicles. They shall deliver the number of bags and the weight of foodgrains etc.; received by them and loaded on their trucks. They shall be liable to make good the value of any shortage, wastage, losses or damage to the goods in transit at **twice the central issue rate for ILS (not RPDS) as fixed by Govt. of India** as applicable from time to time for all foodgrains except when the Regional Manager (whose decision shall be final) decides that the difference between the weight taken at the dispatching and receiving ends is negligible and is due to the discrepancies between the scales, gain or loss in moisture or other causes beyond contractors control.

Approved Clause:-

The contractor shall be responsible for the safety of the goods while in transit in their trucks/ carts/ any other transport vehicles and for delivery of quantity dispatched from the Railhead/ Godowns etc.; as the case may be, to the destination or to the recipients to whom the grain etc.; is required to be transported by the contractor. They shall provide tarpaulins on decks of the trucks, so as to avoid loss of the grain etc.; through the holes / crevices in the decks of the trucks. They shall also exercise adequate care and take precautions to ensure that the foodgrains bags are not damaged while in transit in their trucks/ carts /any other transport vehicles. They shall deliver the number of bags and the weight of foodgrains etc.; received by them and loaded on their truck. They shall be liable to make good the value of any shortage, wastage, losses or damage to the goods in transit at twice the average acquisition cost as applicable from time to time for all foodgrains except when the Regional Manager (whose decision shall be final) decides that the difference between the weight taken at the dispatch and receiving ends is negligible and is due to the discrepancies between the scales, gain or loss in moisture or other causes beyond contractors control.
