While reviewing the Model Tender Document for H&T tender at Corporate Office it has been observed that there is a need for amendment of clause XIV(a) under 'volume of work' at page 53/100 of the MTD and with the approval of the Competent Authority the following changes in MTD are advised to be incorporated with immediate effect.
