Fixation of Minimum Support Prices.**

Government of India has fixed the Minimum Support Prices for the Rabi Crops of Fair Average Quality for 2018-19 Season to be marketed in 2019-20 as under:

Commodity (Fair Average Quality)	MSP
Wheat	1840
Barley	1440
Gram	4620 ✓
Masur(Lentil)	4475
Rapeseed & Mustard	4200 ✓
Safflower	4945 ✓

1.2 The prices of other oilseeds belonging to Rapeseed & Mustard group such as Toria be fixed on the basis normal market price differentials with rapeseed & mustard.

1.3 In the case of cereals including nutri-cereals, FCI and other designated State Agencies would continue to provide price support to the farmers. NAFED, FCI, SFAC and other designated Central agencies would continue to undertake procurement of pulses and oilseeds.

2. The Ministries/Departments concerned are requested that necessary action for providing price support operations as well as for wide dissemination of related information may please be taken.

1.2 रेपसीड/सरसों समूह से संबंधित अन्य तिलहनों जैसे कि तौरिया के मूल्यों को रेपसीड/सरसों के साथ उनके सामान्य बाजार मूल्य अंतरों के आधार पर निर्धारित किया जाय।

1.3 पोषक अनाजों सहित अनाजों के मामले में, एफसीआई एवं अन्य नामित राज्य की एजेन्सियां किसानों को मूल्य समर्थन प्रदान करना जारी रखेगी। नैफेड, एफसीआई, एसएफएसी तथा अन्य नामित केन्द्रीय एजेन्सियां दलहनों एवं तिलहनों की खरीद करने का काम जारी रखेगी।

2. संबंधित मंत्रालयों/विभागों से अनुरोध है कि वे मूल्य समर्थन संचालन सुविधा उपलब्ध कराने के साथ-साथ संबंधित सूचना के विस्तृत प्रचार-प्रसार के लिए आवश्यक कार्रवाई करें।
