Sir,

Public Bonded Warehouses are created mainly to facilitate importers who do not want to clear the imported goods immediately due to factors such as market price, saleability, requirement in the factory of production, etc. However, as on date, most of the warehouses are choked with the bond expired warehoused goods and other goods viz. seized/confiscated goods, etc. The goods have, since long, occupied valuable space without any revenue to the Corporation; which otherwise may be used commercially. In view of the above, urgent action is warranted in this regard.

You are, therefore, requested to furnish a **warehouse-wise** report in respect of the goods lying in the public bonded warehouses in your jurisdiction in the proforma enclosed to the undersigned with a copy to the Customs Bond Cell at e-mail customs.cell@cewacor.nic.in for further action in the matter. The reports received from different warehouses may please be scrutinized thoroughly and the Regional Manager may ensure that each & every entry of the report is factually correct. The report may be submitted to the Corporate Office latest by **15th July, 2020**.
