CIRCULAR – 203

Sub : Examination of rates by FCI i.r.o H&T Contractors appointed by CWC-Reg.

Ref : FCI letter no. एस एंड सी / क्यू.पी/ 06/04/2016/ दिशानिर्देश/ स्टोरेज-XII/ 3362 दिनांक 24.01.2016

Refer to the instructions issued by FCI (Copy enclosed) regarding examination/approval of rates in respect of H&T Contractors appointed by CWC for handling and transportation of FCI stocks stored in the Godowns of CWC, where in it is mentioned that GMs (Region) have right to examine the cost of H&T rates as well as godown rent etc. and if found on higher side , may decide to dehire such godowns so that FCI is not at loss.

Therefore it must be ensured by all RMs (Tender Awarding Authority) that the rates of H&T finalised by CWC are not only commensurate with the market rates but also reasonable vis-à-vis rates of other agencies nearby so that FCI is not compelled to either refrain from availing our H&T services or de-reserve/dehire the godowns due to high rates, notwithstanding the fact that CWC complies with all the guidelines stipulated by CVC and finalises the H&T contract through a transparent online open tender process.

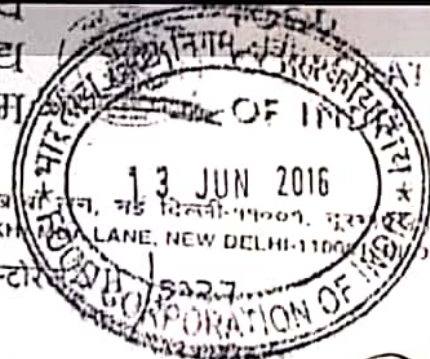

महोदय,

Please refer to the references referred above on the subject cited above. In this regard it is informed that the matter regarding examination/approval of rates by FCI of H&T Contracts awarded by CWC/SWCs for handling and transportation of FCI stocks stored in the godowns of CWC/SWCs has been examined in consultation with finance division and it has been observed that intervention of FCI in CWC working is not appropriate as it is an independent organization, with all duties attached to and abide by CVC guidelines etc. as well as is subject to scrutiny by their auditors.

However, GMs (Region) already have right to examine the cost of H&T rate as well as godown rent etc. and if found on higher side, may dehire such godown so that FCI is not at loss. Accordingly it is advised that concerned authorities of CWC/SWCs may be advised by GM (Region) to float/award the tenders of H&T strictly as per guidelines of CVC.

Further, it is advised that in case it is observed that the CWC/SWC rates are significantly higher than FCI rates the same must be brought to the notice of this office as well as MD, CWC. In case CWC/SWC rates are lower than FCI rates by 10% or more, the concerned Regions may take corrective action as may be needed.
