On page no. 17/99 of circular 192 , after completion of Minimum Eligibility Criteria Clause , it was written “ The documents mentioned at above serial numbers are required under minimum eligibility criteria and are compulsory to participate in the tender process, failing which the tender shall be summarily rejected.	“ The documents mentioned at above serial numbers are required under minimum eligibility criteria and are compulsory to participate in the tender process, failing which the bid shall be summarily rejected . And no further missing documents shall be called for Minimum Eligibility criteria ” .
