Sub: Priorities of replacement/upgradation works in the Regions-reg.

We are operating warehouses on PAN India Basis with a total capacity of 101.40 LMT. Out of which constructed capacity is about 80.00 LMT. We have been creating/constructing the capacities since mid 60's. Thus some of the capacities become unstorageworthy due to non attending the repair and maintenance regularly in the past and now old infrastructure is in dilapidated state. Regions have declared 2, 02, 059 MT capacity as unstorageworthy. Corporate Office is getting regular requests from the Regions for upgrading the infrastructure Immediately so as to use our godowns fully. In view of above, Organization has decided to put the expenditure of major replacements (sheeting, roads and flooring) under CAPEX to enable us to attend the upgradation works urgently and timely. Other day-to-day repairs will be attended as per need in the earmarked fund i.e. 0.75% of the capital cost of the construction(Rs.4481/- MT) by the ROs.

We are identifying the replacement/upgradation works under three categories as per the priority and need of the complexes:

(A) Category-I :	Such centres/warehouses which are declared unstorage worthy or likely to become unstorageworthy for want of attending the urgent upgradation/replacement works.
(B) Category-II	Such centres/warehouses which need immediate replacement/upgradation works of sheeting/roads/flooring. If such replacement/upgradation works are not attended urgently then business is expected to be withdrawn or new business will not come.
(C) Category-III	Such centres/warehouses in which replacement works may be deferred for execution upto last quarter of 2019-20 and 2020-21.

It is therefore requested to send the details of all the due upgradation works under Category-I, II & III, so that a comprehensive planning may be devised at Corporate Office for execution of the above works efficiently and timely in the interest of the business.
