### CIRCULAR

**Sub: 1) Revision of TA/DA and other out of Pocket Expenses for sports persons of CWC (Regular employees and Scholarship players).**

**2) Revision of stipend of scholarship players.**

**Ref: CWC Circular No. CWC/I-Sports/Rectt/08-09 dated 14.05.2008.**

With the approval of Executive Committee, the entitlement of rates have been revised for the Sports persons (Regular employees and Scholarship players) w.e.f. 12.08.2016. The details are as under:-

The following details, which were earlier circulated vide this office circular No. CWC/I-Sports/Rectt/08-09 dated 14.05.2008 would continue

### **1. ACCOMMODATION CHARGES:**

Accommodation charges will be allowed for all matches (one day before and one day after) in respect of outstation tournament. In case accommodation is provided by the host Committee, no accommodation charges will be admissible.

### **2. DAILY ALLOWANCE (FOR OUTSTATION TOURNAMENT)**

One day before and one day after the tournament of actual days of tournament.

Note: The daily allowance will be worked out right from the commencement of journey as per details given below:

i. Less than 6 hours	30%
ii. 6 to 12 hours	50%
iii. 12 hours and above	100%

### **3. Daily Allowance for local tournament shall be payable:**

For actual days of matches only.

4. Daily allowance, refreshment will be provided during actual days of coaching camps organized by CWC.

5. **Pocket allowance:** Out of pocket allowance is admissible to National/International coaching camp for the duration subject to production of attendance certificate issued by concerned Federation/Body/Association.

6. **Kit Allowance:** The playing kit, track suit and blazer will be provided to players only and The Team Manager and Coach are entitled for track suit and blazer against production of receipts subject to ceiling amount.
7. The schedule of allowances shall be applicable for the players representing CWC i.e. regular & stipend players. Other allowances apart from above/conditions approved by E.C. in its earlier meeting shall remain the same.

**Financial/Administrative powers of Secretary (SPB)**

Financial/Administrative powers of Secretary (SPB) will remain as per Circular No. CWC/I-Sports/Rectt./2000 (Agenda Item No.II-1 of 141<sup>st</sup> meeting of the EC held on 23.12.99)- Annexure-IV.

Further, the Secretary (SPB) he will also have administrative powers to allow practice, leave other than study leave etc. Besides all decisions relating to sports persons would be taken with the concurrence of Secretary (SPB).
