Consequent upon their promotion, their pay will be fixed in the aforesaid pay scale in accordance with Regulation 25 of CWC (Staff) Regulations, 1986. In case they want pay fixation on promotion under FR - 22(1)(a)(i) i.e. after drawal of next increment in the lower grade, they can exercise option for the same within 30 days of their joining the new post.

The above officials shall be on probation for the period of one year with effect from the date they assume charge of the new post and the period of probation is extendable further upto one year as per Regulation 10 of CWC(Staff) Regulations, 1986 except at S.No.2, 3, 6, 28, 45, 46, 48, 52, 56, 57, 61, 76, 77, 78, 79, 80 and 81 respectively who will be on probation till their retirement.

Those WAG-Is who have already been given higher scale without change of Designation under ACP Scheme, on promotion as Jr. Supdt. they will not be entitled for pay fixation.



As per CWC circular No.CWC/I-Policy/Prom./Rectt./2012 dt. 15.02.2012 that the officials should join their duty on promotion within 30 days from the date of issue of promotion orders, by RM concerned failing which the promotion will be treated as foregone.

The above officials should join their duty immediately and submit their joining report to all concerned.
