Consequent upon their promotion, their pay will be fixed in the aforesaid pay scale in accordance with Regulation 25 of CWC (Staff) Regulations, 1986. In case they want their pay fixation on promotion under FR-22 (1)(a)(i) i.e. after drawl of next increment in the lower grade, they can exercise option for the same within 30 days of their joining the new post.

They shall be on probation for a period of one year with effect from the date they assume the new post. The period of probation is extendable further up to one year as per Regulation 10 of CWC (Staff) Regulations, 1986.

As per CWC circular No.CWC/I-Policy/Prom./Rectt./2012 dt. 15.02.2012 the officials should join their duty on promotion within 30 days from the date of issue of promotion orders, by RM concerned failing which the promotion will be treated as foregone.

The above officials should join their duty immediately and submit their joining report to all concerned
