CIRCULAR

Sub: Empanelment of Hospital under Direct Payment System for Indoor Treatment for the Corporation's employees and their dependents.

With the approval of the Competent Authority, the following hospitals have been empanelled / renewed for a period of two years w.e.f. 22.07.2019 to 21.07.2021 for indoor treatment of employees and their dependents. The facility has been extended to ex-employees of CWC and their dependents also on the same rate but on cash payment basis on the following terms and conditions only: -

Note:

1. Wherever, CGHS Rates are quoted, it is as per CGHS NABH 2014 Rates.
2. In case of in-patient treatment, charges payable to hospital for IPD Consultation per specialities shall be limited to two consultations per day.

ISSUE OF AUTHORITY LETTER

The employees are to be admitted by the hospital for indoor treatment as per the entitlement of room category mentioned above limited to entitled room charges and for this purpose, proper Authorization Letter to be issued by the officials, duly authorized for the same by Personnel Division, CO/RMs for the employees under their jurisdiction.


The category of room entitlement is mentioned above, there should be a mention about the name of the employees, designation, category of room charges. There should also be a mention of the maximum ceiling of room rent.

If the accommodation of entitled category is available and employee insists for higher category of room, the differential amount of room charges would be borne by the employees, which will be collected by the hospital at the time of his/her discharge.

Where the hospital has charged CGHS NABH/NABL Rates, the same shall be paid to the hospital after obtaining a certificate from the empanelled hospital that they are accredited to such categories. Alternatively, it can also be verified from the CGHS Website. This may be ensured by all concerned.

As per CO Circular dated 23.10.2013, all RMs are competent to issue Authority Letters to the concerned hospitals empanelled by CO, New Delhi.

The Indoor Treatment for the employees and their dependents may be taken for illness of specialized diseases, which cannot be treated at OPD. The Authorization Letter shall be issued for Indoor Treatment on the recommendation of the concerned doctor of the hospital and not for the investigation, diagnostic procedures etc.
