Consequent upon their promotion, their pay will be fixed in the aforesaid pay scale in accordance with Regulation 25 of CWC (Staff) Regulations, 1986. In case they want pay fixation on promotion under FR 22(1)(a)(i) i.e. after drawl of next increment in the lower grade they can exercise option for the same within 30 days of their joining the new post; **except officials whose pay have already been fixed in the above scale under ACP Scheme.**

The above officials shall be on probation for a period of two years w.e.f. the date of they assume charge of the new post. The period of probation is extendable upto a further period not exceeding one year as per Regulation of 10 (ii) of CWC (Staff) Regulations, 1986. Those officials who are due to superannuate within a period of two years from the date of joining on the new post shall be on probation till the date of superannuation.

They should report to join their duty as **Senior Assistant Manager (G)** within 45 days from issuance of this order failing which it will be presumed that they are not interested to join on their promotion and their promotion will be treated as foregone without any notice as per policy of the Corporation.

The above officials should submit their joining report/charge report to all concerned immediately.
