CIRCULAR

SCHEME FOR AWARD OF MERIT SCHOLARSHIP TO THE WARDS OF EMPLOYEES OF CWC FOR PURSUING STUDIES IN PROFESSIONAL DIPLOMA/DEGREE/POST GRADUATE COURSES IN ENGINEERING, MEDICINE, DENTAL, AGRICULTURE, LAW, MANAGEMENT, COMPUTER APPLICATION AND ALLIED FIELDS ETC.

Applications in the enclosed prescribed proforma are invited 'as per the existing scheme' from the wards of the employees of the Corporation eligible for grant of Merit Scholarship for professional courses, commencing from the Academic Year 2012-13. Applications duly completed in all respects along with certificate from the Head of the Institution in which the candidate has got admission enclosing photocopies of documents listed below should be submitted through RM/EE/WM as the case may be. Applications completed in all respects be submitted well in time, so as to reach the undersigned latest by 15.03.2013. Any application received thereafter will be summarily rejected.

- 1. Certificate/Degree of the qualifying examination i.e. SSC or Intermediate or Diploma or Degree etc.
- 2. Mark-sheets of qualifying examination i.e. SSC or Inter or Diploma or Degree (In case of Diploma or degree as qualifying examination, Mark sheets for all the semesters of the course or a consolidated marks sheet indicating semester wise/yearwise marks are/is to be furnished).
- 3. Letter of the Agency conducting the Joint Entrance Exams such as EAMCT/AIEEE/CAT/ MAT/Tech. Universities etc. referring the ward to the concerned Institute for admission, is to be furnished in case the admission is taken through JEE and the consolidated marks in the qualifying examination i.e. SSC, Inter, Diploma or Degree etc. is less than 70% or 7.00 as CGPA in the grade scale of 10.00 in case of General, and less than 60% or 6.00 as CGPA in the grade scale of 10.00 in case of wards belonging to SC/ST category.

The contents of the circular alongwith the enclosures may be brought to the notice of all employees and it may also be advised that once the merit scholarship is awarded for a particular course, there is no need to apply again during the currency of the said course.

Note:- Wards who have not obtained admission through Entrance Exams and have less than prescribed minimum %age of marks in qualifying examination i.e. 70% or 7.00 as CGPA in the grade scale of 10.00 in case of general category and 60% or 6.00 as CGPA in the grade scale of 10.00 in case of SC/ST category need not apply for this merit scholarship. They may instead apply to concerned Regional Offices for Merit Scholarship @ equivalent to that of non professional courses.

विद्यमान योजना के अनुसार' शैक्षिक वर्ष 2012—13 से शुरू हो रहे व्यावसायिक पाठ्यकमों के लिए निगम के कर्मचारियों के पात्र पुत्रों / पुत्रियों से योग्यता—छात्रवृत्ति प्रदान करने के लिए संलग्न निर्धारित प्रोफार्मा में आवेदन पत्र आमन्त्रित किए जाते हैं। जिस संस्था में उम्मीदवार ने प्रवेश लिया है, उसके प्रमुख के प्रमाण—पत्र सहित निम्नलिखित दरतावेजों की फोटो प्रतियां संलग्न करते हुए हर दृष्टिकोण से पूर्ण आवेदन पत्र क्षेत्रीय प्रबन्धक / कार्यकारी अभियंता / वेअरहाउस प्रबन्धक के माध्यम से जैसा भी मामला हो,अग्रसारित किये जाएं। पूर्ण रूप से भरे गए आवेदन पत्र अधोहस्ताक्षरी के पास 15.03.2013 तक पहुंच जाने चाहिएं। इसके बाद प्राप्त आवेदन पत्रों को एकदम निरस्त कर दिया जाएगा:—

- क्वालिफाइंग परीक्षा अर्थात् एस.एस.सी. अथवा इंटरमीडिएट अथवा डिग्री अथवा डिप्लोमा आदि का प्रमाण पत्र / डिग्री।
- 2. क्वालिफाइंग परीक्षा अर्थात् एस.एस.सी. अथवा इंटर अथवा डिप्लोमा अथवा डिग्री की मार्कशीट (यदि डिप्लोमा अथवा डिग्री क्वालिफाइंग परीक्षा है, पूरे पाठ्यकम के सभी समेस्टरों की मार्कशीट अथवा समेस्टरवार / वर्षवार समेकित मार्कशीट) प्रस्तुत की जाए।
- 3. यदि संयुक्त प्रवेश परीक्षा द्वारा दाखिला लिया गया है तथा सामान्य उम्मीद्वारों के लिए क्वालीफाइंग परीक्षा जैसे एसएससी,इन्टर,िडप्लोमा अथवा डिग्री इत्यादि में 70 प्रतिशत अथवा 10.00 ग्रेड स्केल पर 7.00 सीजीपीए तथा एससी/एसटी वर्ग के बच्चों के लिए 60 प्रतिशत अथवा 10.00 के ग्रेड स्केल पर 6.00 सीजीपीए से कम अंक हैं तो संयुक्त प्रवेश परीक्षा आयोजित करने वाली एजेंसी जैसे ईएएमसीटी/ एआईईईई/केंट/मैट/तकनीकी विश्वविद्यालय का पत्र जिसके द्वारा प्रवेश के लिए बच्चे को संबंधित संस्थान में भेजा गया है, प्रस्तुत किया जाए ।

कृपया इस परिपत्र एवं अनुलग्नकों की विषयवस्तु से सभी कर्मचारियों को अवगत कराया जाए तथा यह भी सलाह दी जाए कि यदि किसी पाठ्यकम विशेष के लिए छात्रवृत्ति एक बार प्रदान की जा चुकी है तो उसके पाठ्यकम के चालू रहने के दौरान दोबारा आवेदन—पत्र देने की आवश्यकता नहीं है।

टिप्पणी : ऐसे बच्चे जिन्होंने प्रवेश परीक्षा के माध्यम से प्रवेश नहीं लिया है तथा क्वालिफाइंग परीक्षा में सामान्य श्रेणी के लिए निर्धारित न्यूनतम प्रतिशत अंक अर्थात् 70% अंक अथवा 10.00 के ग्रेड स्केल पर 7.00 सीजीपीए तथा अनु. जाति / जनजाति श्रेणी के लिए 60% अंक अथवा 10.00 के ग्रेड स्केल पर 6.00 सीजीपीए प्राप्त नहीं किये हैं वे इस मेरिट छात्रवृत्ति के लिए आवेदन न करें। वे अव्यवसायिक पाठ्यकमों की समतुल्य दरों पर मेरिट छात्रवृत्ति के लिए संबंधित क्षेत्रीय कार्यालयों को आवेदन कर सकते हैं।
