
This is continuation to the Trust circular No. CWC-EBT/Med.Reimb/2016-17 dated 24.10.2016. It has been decided in the 20th meeting of CWC Employees Benevolent Trust held on 31.03.2017 to extended the Medical Reimbursement Scheme to employees for Chronic diseases for the FY 2017-18 alongwith the revised limit of medical expenditure borne by employee as under:-

Sl. No.	Particulars	Present Limit	Revised Limit
1.	Expenditure on chronic diseases Borne by the concerned employee.	Upto first Rs. 7,500/-	Upto first Rs.5,000/-
2.	Reimbursement by EBT CWC to employees incurring expenditure from Rs.5,001/- to Rs. 80,000/-.	Rs.75,000/-	Rs.75000/- (Maximum) or actual whichever is less. (unchanged)

The revised limit of Rs.5000/- (Rs. Five thousand only), borne by employee shall be made applicable for the claim of medical bills prescribed by Doctor on or after 01.04.2017. Other terms & Conditions of the scheme will remain unchanged.


