CIRCULAR

Sub: - Renewal/Empanelment of following Hospitals under "Direct Payment System" for indoor treatment of Corporation's employees and their dependents.

With the approval of the Competent Authority the empanelment of following hospitals has been renewed for the further period of one year w.e.f **01.04.2016 to 31.03.2017** for the indoor treatment of employees and their dependents. The facility has been extended to Ex-employees of CWC and their spouse also on the same rate but on cash payment basis only. The empanelment of following hospitals comes into effect from **01.04.2016**.

The room rent charges has been revised by the CWC vide circular dated 23.09.2014. The CGHS Rates have been revised w.e.f. 1.10.2014.


“In case the eligible accommodation is not available at the time of admission the patient will be admitted to lower category of accommodation. But if patient is provided higher category accommodation at his/her own request, the differential amount will be borne by the beneficiary and the difference amount will be collected by the hospital at the time of his/her discharge. If the higher category accommodation is provided by the hospital in the event of non-availability of entitled accommodation, the differential amount will be borne by the hospital concerned.”

The hospitals are listed categories wise in CGHS as NON-NABH, NABL, NABH. The rates charged by these hospitals shall be reimbursed accordingly after obtaining the certificate from empanelled hospitals as to whether they are actually listed in CGHS as categories wise. The same may also be seen at CGHS website. All concerned are requested to take appropriate action at their end.

The other terms and conditions as contained in the circular dated 14.05.1999.

As per CO circular dated 23.10.2013, all RMs/CC Heads are competent to issue authority letters to the concerned hospitals empanelled by CO, New Delhi.

The indoor treatment for the employees and their dependent may be taken for illness of specialized diseases, which cannot be treated at OPD. The authorization letter shall be issued for indoor treatment on the recommendation of the concerned Doctor of the hospital and not for the investigation, diagnostic procedures etc.
