2.	Employees incurring expenditure from Rs.7501/- to 82,500/- during FY 2016-17 to be reimbursed by CWC EBT.	RS.50,000/-	Rs.75,000/- (Maximum) or actual whichever is less

Revised scheme of reducing limit of Rs.7500/- (Rs. Seven thousand five hundred only) at SINo.1 above shall be made applicable for the claims made by the claimants on or after 07.10.2016. Old cases settled will not be reopened.
