Sir,

This refers to the e-tender enquiry mentioned at Ref. 1 above wherein M/s ARR Fabcon Consortium had participated and the Strategic Alliance Management Contract was awarded to the said consortium vide letter under reference 2.

The Consortium was supposed to execute the agreement and furnish the required BG within 30 days of the award of the contract. Further, on the request of the consortium the time for execution of agreement and furnishing of required Bank Guarantee was extended for a period of four weeks vide e-mail under reference 3. However, the consortium did not come forward to execute the agreement and furnish the BG within the prescribed time limit.

Therefore, as per the tender clause 5.7 (iii) and with the approval of the Competent Authority the Earnest Money Deposit (EMD) amounting to Rs.6 lakh stands forfeited and also both the members of the ARR-Fabcon Consortium namely M/s ARR Maritime & Allied Services Pvt. Ltd. as well as Fabcon Consultants & Engineers Pvt. Ltd. are debarred from participation in all future tenders of CWC for a period upto 30.09.2019.
