**CIRCULAR**

**Sub: - Empanelment of Hospitals under "Direct Payment System" for indoor treatment of Corporation's employees and their dependents.**

In continuation to this office Circular of even No. 524D dated 10.04.2017 & 114D dated 08.06.2017 vide which renewal of 19 + 13 additional hospitals were empanelled now one additional hospital has also been empanelled with the approval of the Competent Authority for the period from **19.07.2017 to 31.03.2019** for indoor treatment of employees and their dependents. The facility has been extended to Ex-employees of CWC and their spouse also on the same rate but on cash payment basis only:-

**Note :**

- Wherever CGHS Rates are quoted; it is as per CGHS NABH 2014 rates.
- In case of Inpatient treatment; charges payable to hospital for IPD Consultation per specialist, shall be limited to 02 consultancy per day.
- Free ambulance services shall be provided in case of admission within Gurgaon.

The room rent charges has been revised by the CWC vide circular dated 23.09.2014. The CGHS Rates have been revised w.e.f. 1.10.2014.

**Issue of authority letter**

The employees are to be admitted by the hospital for indoor treatment as per the entitlement of room category mentioned above, limited to entitled room charges and for this purpose, proper authorisation letter to be issued by the officials duly authorised for the same by Personnel Division, CO/RMs/CC Heads for the employees under their jurisdiction.

The category of room entitlement is mentioned above, there should be a mention about the name of the employees, designation, category of room charges. There should also be a mention of the maximum ceiling of room rent.

**If the accommodation of entitled category is available and employee insists for higher category of room, the differential amount of the room charges would be borne by the employee which will be collected by hospital at the time of his/her discharge.**

Where the hospitals has charged CGHS NABH/NABL rate the same shall be paid to the hospital after obtaining a certificate from the empanelled hospital that they are accredited to such categories. Alternatively it can also be verified from CGHS website. This may be ensured by all concerned.

The other terms and conditions as contained in the circular dated 14.05.1999.

As per CO circular dated 23.10.2013, all RMs/CC Heads are competent to issue authority letters to the concerned hospital empanelled by CO, New Delhi.

The indoor treatment for the employees and their dependent may be taken for illness of specialized diseases, which cannot be treated at OPD. The authorization letter shall be issued for indoor treatment on the recommendation of the concerned Doctor of the hospital and not for the investigation, diagnostic procedures etc.
