CIRCULAR

Subject: Clarification regarding Pay fixation on Promotion Consequent to Amendment in Regulation 10(i) of CWC (Staff) Regulation, 1986 Vide Notification Dated 18.12.2019

- 1. Probation period prescribed for different posts for Direct Recruitment and Promotion has been amended consequent to the amendment in Regulation 10(i) of CWC (Staff) Regulation, 1986 vide notification dated 18.12.2019. Certain clarifications/queries have been raised regarding pay fixation post above amendment.
- 2. Apropos, the matter of pay fixation post amended in probation period was deliberated in detail. Accordingly, with the approval of the competent authority and concurrence of Finance Division illustration of pay fixation in all possible scenarios is placed at **Annexure-I**.
- 3. The officials who have joined on promotion after amendment in Regulation 10(i) i.e. 18.12.2019 are hereby given an opportunity to opt for pay fixation under FR 22(I)(a)(1) in case deemed beneficial to them. Requests in this regard shall reach to concerned authority within one month from the date of issue of this communication. The Corporation will be constrained to entertain any requests for pay fixation under FR 22(I)(a)(1) afterwards.
