The payment of IDA to the entitled Officers of the Corporation who have been allowed the benefit of revised pay scales vide this Office Order No.CWC/I-IDA Revision/Rectt./2008-09 dated 8th May,2009 w.e.f. 1.1.2007 on IDA pattern of pay scale governed by DPE's OM dated 26.11.2008 and 2.4.2009 may be regulated in accordance with the terms enumerated by the Department of Public Enterprises in the above said OMs.

The payment of IDA to Group C&D employees who have also been allowed the benefit of revised pay scales vide letter No.CWC/IRO-W. Implementation/ 2009 dated 3.11.2009 w.e.f. 1.1.2007 may also be regulated as per revised DA rate indicated in the aforesaid OM in terms of para.6 of the letter dated 3.11.2009.

OFFICE MEMORANDUM

Subject:- Board level and below Board level posts including non-unionised supervisors in Central Public Sector Enterprises (CPSEs)- Revision of scales of pay w.e.f. 01.01.2007 – Payment of IDA at revised rates-regarding.

In modification of this Department's O.M. of even No. dated 05.10.2017, the rate of DA payable to the executives and non-unionized supervisors of CPSEs (2007 pay revision) is as follows:

a) **Date from which payable:** 01.01.2018

b) **Average AICPI (2001=100) for the quarter Sept.'2017 – Nov.' 2017**

Sept., 2017	285
Oct., 2017	287
Nov., 2017	288
Average of the quarter	286.67


c) **Link Point:** 126.33 (as on 01.01.2007)

d) **Increase over link point:** 160.34 (286.67 minus 126.33)

e) **DA Rate w.e.f. 01.01.2018:** 126.9% [(160.34 ÷ 126.33) x 100]

2. The above rate of DA i.e. 126.9% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.M. dated 26.11.2008, 09.02.2009 & 02.04.2009.

3. All administrative Ministries/ Departments of the Government of India are requested to bring the foregoing to the notice of the CPSEs under their administrative control for necessary action at their end.




