Consequent upon their promotion, their pay will be fixed in the aforesaid pay scale in accordance with Regulation 25 of CWC (Staff) Regulations, 1986. In case they want their pay fixation under FR-22 (I)(a)(i) i.e. after drawal of next increment in the lower grade, they can exercise option for the same within 30 days of their joining the new post.

Those Tech.Asst./Jr.Suptd. who have already been given higher scale without change of Designation under ACP Scheme on promotion as Superintendent will not be entitled for pay fixation.

They shall be on probation for a period of one year, except Sr.6,10,11,12,14,17,19,21,24,25,31 to 33,41, 51,56,59,60,65,77,81,86,89 & 92 who shall be probation till their retirement, with effect from the date they assume charge of the new post. The period of probation is extendable further upto one year as per Regulation 10 of CWC(Staff) Regulations,1986.

The competent authority has desired that the officials should join their duty as Supdt. within one month of issuance of this order failing which it will be presumed that they are not interested to join on their promotion and their promotion will be treated as foregone.

The above officials should proceed to their new place of postings and submit their relieving/joining report to all concerned immediately.
