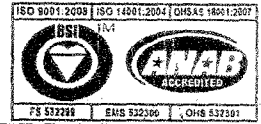

You are requested to take action accordingly.



In continuation of circular no. CWC/XXIV-106/Estt(Spl.CL) dated 5.4.1975 and 18.10.1995 regarding grant of Spl. CL to the office bearers of recognized trade unions, it has been decided that the issue of Special CL of the office bearers of recognized trade unions may be regulated in accordance to Central Civil Services (Leave) Rules 1972 read with Regulation 31 of CWC (Staff) Regulations 1986.
